Dear members and friends of the European Land and Soil Alliance,

In 2021, the European Commission presented the EU Soil Strategy for 2030. Its vision is that by 2050, all soil ecosystems in the EU will be in a healthy state and therefore more resilient.

According to estimates by the European Commission, 60 to 70 per cent of soils in Europe are not considered healthy. The aim is to make soil ecosystems in the EU healthy and resilient, to prevent soil contamination in the future and to remediate soils that are already polluted.

Healthy soils are an essential prerequisite for climate neutrality, a clean and circular economy and the containment of desertification and soil degradation. They thus contribute to the objectives of the European Green Deal.

The only harmonised legal framework for soil protection at EU level is still only the Common Agricultural Policy (CAP) of the Member States. The draft Soil Monitoring Law presented by the EU Commission in 2023 provides neither quantitative targets nor concrete measures, but only the monitoring of the condition of our soils.

It is therefore all the more pleasing that the EU Council of Ministers adopted the Restoration Act, a core element of the Green Deal, on 17 June 2024. By 2030, at least 20 per cent of land and sea areas in the EU are to be restored and by 2050 all ecosystems in need of restoration - including our soils.

# **Top-Topic: Soil protection in Europe**

**EU member states pass renaturalisation law:** The environment ministers of the European Union have passed the renaturalisation law that has been under dispute for months. According to this law, more trees are to be planted in the European Union in future and moors and rivers are to be restored to their natural state. A sufficient majority of EU member states voted in favour of the plan.

**Soil Monitoring Law - EU on the way to healthy soils by 2050:** With the general approach it adopted on 17 June 2024, the Council of the European Union wants to make soil health monitoring mandatory, set guidelines for sustainable soil management and address situations where soil contamination poses unacceptable risks to health and the environment.

**EEB statement:** Based on the EU Council's decision to adopt the Soil Monitoring Law on 17 June 2024, the European Environmental Bureau (EEB) has published a statement and assessment. The EEB welcomes the achievement of a compromise, but regrets that Member States have failed to increase the much-needed ambition of the law.

**EU Parliament - Position on Soil Monitoring Law:** The EU Parliament has defined its position on the new Soil Monitoring Law. MEPs are proposing a five-level classification system to assess the condition of soils. They call for concrete targets to improve the ecological status of soils in the EU in order to bring all soils into a healthy state by 2050.

Online participation in the further development of the German Sustainable Development Strategy: The Federal Government has published the dialogue version of the German Sustainable Development Strategy (DNS). Interested parties can comment on the dialogue version and contribute their ideas for a sustainable, future-proof Germany. Participation is possible until 26 July 2024.

**ECHO Soil Health Awareness Project:** ECHO is a research and innovation project funded by the European Union under the Horizon Europe programme. The project will run for 4 years - from June 2023 to May 2027 - and aims to engage citizens in the protection and restoration of Europe's soils by developing their skills and increasing their knowledge. ECHO ambassadors are currently being sought to take on various tasks from April 2024 to January 2025 to support the project.
